

WB region at glance

- > HE system harmonized with BP
 - ✓ 3 cycles
 - ✓ DS
 - **✓** ECTS
- > Two types of institutions:
 - ✓ Universities (faculties)
 - ✓ Colleges of applied (professional) studies
- > Around 700.000 students
- Academic year starts in October








Participation of WB HEIs

Balanced numbers:









International credit mobility

Percentage Share of Awarded Grant




Percentage Share of Awarded Grant

Issues and challenges

- Applying with partners that are not HEIs or separate Faculties
- Number of courses offered in English in WB HEIs
- Interest for mobility is not so big with students and staff
- Issues with recognition of grades need for systematic approach
- Language competences
- Different academic calendars
- Wrong inter-institutional agreements



Position of Serbia in the Erasmus+

- ➤ 2017 call— Serbia is a partner country but in preparatory phase for full participation; will most probably be eligible for KA2 Strategic Partnerships from 2018 call but only as the applicant
- Full participation in Capacity building projects, eTwinning and some policy networks like Euroguidance and Eurydice
- Partial participation in knowledge alliances, strategic partnerships and sector skills alliances for now
- Partner country in Joint master degrees.
- Eligible for Jean Monnet

- Definition, implementation and monitoring of the reform policies



Some topics relevant for HE reform

- ✓ Improvement of the accountability of HE institutions
- ✓ Further development/rationalization of student services
- ✓ Adaptation of the enrollment policy into the HE
- ✓ Initial pedagogical training of teachers that will work at universities and colleges
- ✓ Financing of HE
- ✓ Curriculum development/modernization (Law, Journalism, Marketing...)

- Request for cooperation to the Ministry of Education is to be submitted by 15 december by e-mail to razvoj@mpn.gov.rs (please put neo serbia@tempus.ac.rs in copy)
- The role of the Ministry needs to be clearly described and the links with the Strategy on Education Development and its Action plan http://erasmusplus.rs/important-for-project-contents/national-documents/?langkl=lat
- Basic data about the project proposal need to be provided to the Ministry— a short overview with objectives and expected outputs, planned overall budget, list of project partners






NEO Serbia general observations concerning CBHE proposals

- ✓ Need for real involvements of relevant authorities/ministries, social partners, stakeholders, companies, enterprises
- ✓ Effective involvement of students/ student representative bodies
- ✓ Insistence on cost-effectiveness and wider impact especially in respect of target groups (and bearing in mind a project budget)
- ✓ Capacity/level of institutions for addressing certain topics of the projects
- ✓ Sustainability of results
- ✓ Overlapping with Tempus or other EU funding needs to be avoided
